Govt's position clear — mob lynching shouldn't happen: CM

EXPRESS NEWS SERVICE JAIPUR, AUGUST 16

RAJASTHAN CHIEF Minister Ashok Gehlot has said that his government's position is clear — mob lynchings should not take place.

"When Rajasthan can be the first state after Manipur to make a law on mob lynching, you can understand that it's the government's clear position that no type of mob lynching should happen. If two or more people start assaulting a person and a life is lost, what could be more condemnable than this? The government has done due deliberation and passed this law. In the Pehlu Khan case too, the government has decided that we

will appeal against the verdict," Gehlot told mediapersons on Thursday.

Earlier, speaking at an Independence Day function, the chief minister said that over the past five years, an economic slowdown has affected the economy and cited incidents such as demonetisation and GST to criticise the policies of the Centre.

Gehlot extensively spoke about the various initiatives and programmes launched by the previous UPA government in the Centre and said that leaders such as Indira Gandhi, Jawaharlal Nehru, Rajiv Gandhi and Manmohan Singh built the foundation of the country.

He also said that if the government at the Centre is weak, then the states too are affected.

Heavy rain lashes Rajasthan, five people killed

FIVE PEOPLE were killed in rain-related incidents over the past 24 hours in Rajasthan, which was lashed by incessant rainfall, creating a flood-like situation in Hadauti region of the state, an official said on Friday.

According to data by the MeT department, as of 8.30 am Friday, 124 mm rainfall was recorded in Chittorgarh, 118 mm in Mount Abu, 117 mm in Bhilwara, 79.8 mm in Dabok, 72 mm in Erampura Road, and 58 mm in Kota.

A red alert warning was issued for Jodhpur, Nagaur and Pali for the next 24 hours, according to the MeT department. The Army was asked to be vigilant as Kota, Baran, Bhilwara, Jhalawar and Bundi districts recorded more than 160 mm of rain since Thursday.

Disaster Management, Support and Civil Protection Department Secretary Ashutosh A T Pednekar said five people were killed in rain-related incidents. He said the district administrations were in constant contact with Madhya Pradesh in connection with the continuous flow of water from the state.

India suspends services of Thar Link Express

THE THAR Link Express, the weekly train that connected Jodhpur to Pakistan's Karachi, was suspended by India on Friday, a week after Pakistan authorities suspended services of the train from their side.

The train was scheduled to depart on Friday night from Bhagat ki Kothi railway station in Jodhpur for Munabao in Barmer, said railway officials.

"Services of the Thar Link Express have been suspended till further orders and the train which was supposed to leave to-day night has been cancelled. Around 35 passengers had booked tickets for tonight's train," said Abhay Sharma, chief PRO, North Western Railways.

The train used to run till Munabao, following which, it would cross into Pakistan, from where the Pakistani railway services took it to its final destination of Karachi.

Pakistan had suspended the service a day after it also suspended the Samjhauta Express, following its decision to downgrade bilateral ties with India.
